Admissions Policy

Preamble

This policy is consistent with:

- The Higher Education Support Act (HESA) 2003
- The Higher Education Standards Framework (Threshold Standards) 2021
- The Education Services for Overseas Students Act 2000 (ESOS Act)
- The National Code of Practice for Registration Authorities and Providers of Education and Training to Overseas Students 2018 (National Code)
- The Migration Regulations 1994
- The VTAC Rules and Procedures Manual for VTAC Institutions
- The VTAC Conditions of Participation as an Associate Institution

Purpose

This policy establishes the principles, criteria and processes guiding the admission of an applicant into a course at Deakin College.

Scope

This policy applies to all courses and all campuses of Deakin College.

Policy

1. Principles

- **1.1.** This Policy is underpinned by the following principles:
 - Assessment for admission is consistent with the relevant legislation;
 - Detailed and comprehensive course information, including academic, English language entry requirements and course delivery are provided to students prior to admission via the Deakin College website and Deakin College brochures (see Admissions Procedure);
 - All applications will be assessed fairly, objectively and on its merits;
 - Applicants will be advised in writing of the outcome of their application;
 - Deakin College admits students who have the appropriate educational qualifications and/or work experience and, English language proficiency to undertake and complete the course.

2. Mode of Application

- **2.1.** An application for admission to a Deakin College course may be submitted via the following avenues:
 - Victorian Tertiary Admission Centre (VTAC)

Current Year 12 student, including overseas students currently studying the Victorian Certificate of Education (VCE) or the International Baccalaureate (IB) program in Victoria



and, non-year 12 applicants are to apply through the Victorian Tertiary Admissions Centre (VTAC) by the nominated closing date for entry in trimester 1 of any given year.

Applicants who have applied through VTAC but have not listed a Deakin College course on their preference list, may access the VTAC Supplementary Offer process after the change of preference period has closed.

VTAC applicants who wish to change their preference and select a Deakin College course, which was lower than the one offered in the first/main round offers may also access the VTAC Supplementary Offer process.

• Directly to Deakin College

Current Year 12 student, including overseas students currently studying the Victorian Certificate of Education (VCE) or the International Baccalaureate (IB) program in Victoria and, non-year 12 applicants who did not access the VTAC system after the VTAC 'very late' closing date may apply directly to Deakin College.

• Deakin College or Navitas Education Agent

Overseas students may apply through one of the approved Deakin College Education Agents. Details of approved Deakin College Education Agents are listed on the Deakin College website.

3. Admission Criteria

3.1. Academic

- For entry into a Deakin College Diploma course, students must demonstrate successful completion of Year 12, or equivalent.
- For entry into the Deakin College Foundation Program, students must demonstrate successful completion of Year 11, or equivalent.
- For overseas students, specific academic entry requirements will vary with each country as per the Academic Entry Requirements (Schedule A).

3.2. Age

- Deakin College does not apply a minimum age requirement to an applicant seeking admission to its courses.
- All applications from students under 18 years of age must be approved and signed by parents or legal guardians. Special arrangements for the care and welfare of under 18 years of age students are required in Australia. The *Care of Students Under the Age of 18 Policy* details the arrangements and processes put in place to ensure that these students have the appropriate accommodation, support and supervision.

3.3. English Language

• All students must demonstrate a suitable level of English language proficiency before being admitted to course at Deakin College as specified in the English Language Entry Requirements (Schedule B).



- Students are required to provide results of an English language test from a range of English language test providers.
- Deakin College will accept English language test up to two years prior to trimester of commencement.

3.4. Mature Age Consideration

- Applicants who do not meet the academic requirements under subsection 2.1 of this policy may be admitted to a course on the basis of demonstrable expertise and relevant work experience.
- An applicant must be 21 years of age and over.
- Applicants are required to provide the following:
 - Employer's name and contact details;
 - job title;
 - a personal statement and information on work experience;
 - length of employment;
 - duties undertaken in the role;
 - References and/or a statement from the employer substantiating the work claim will also be required.
- A mature age applicant who is unable to demonstrate work experience may be considered for mature age entry through the VTAC Special Entry Access Scheme (SEAS), category 1: Personal information and location (Age) (please refer to section 5.5 of this policy).
- The Academic Director will assess work experience claimed by the applicant based on the evidence provided. The Academic Director will provide reasons for not accepting an applicant's work experience as suitable for admission.

3.5. VTAC Special Entry Access Scheme (SEAS)

- For VTAC applicants, Deakin College will consider a range of VTAC alternative entry SEAS categories, taking into account an applicant's short and long-term educational disadvantage.
- The SEAS program allows Deakin College to grant extra consideration for course entry to applicants, but it is not a replacement for course entry requirements.
- The categories of alternative entry and specific institutional requirements are published in the VTAC Guide (<u>www.vtac.edu.au</u>).

3.6. Genuine Student

• A 'genuine student' is an overseas student applicant who intends to obtain a successful education outcome at Deakin College and Deakin University and has the language,



educational and financial background to have a reasonable chance of achieving this educational outcome.

- Assessment of the genuine student criteria takes into account a student's visa history including but is not limited to:
 - previous visa applications;
 - compliance with student visa conditions; or
 - previous student visa breaches.

4. Verification of Overseas Qualifications

- **4.1.** All applications must include translated and certified copies of all academic transcripts and certificates obtained. Outside Australia, the following people are authorised to certify documents:
 - a justice of the peace;
 - notary public;
 - Australian Consular Officer or Australian Diplomatic Officer (within the meaning of the Consular Fees Act 1955);
 - employee of the Commonwealth or the Australian Trade Commission;
 - a Deakin College or Navitas Educational Agent.

5. Recognition of Prior Learning

- **5.1.** The provisions of the *Recognition of Prior Learning Policy* detail the grounds on which credit for prior learning will be considered, requirements for award at Deakin College and the recognition of prior learning application process.
- **5.2.** Applicants are encourage to apply for recognition of prior learning at least one (1) month prior to the commencement date of their studies or no later than the official trimester finish date in the first trimester of study.

6. Written Agreements

- **6.1.** All applicants admitted to Deakin College is provided with a written agreement which includes an Offer Letter.
- **6.2.** The written agreement must be signed or otherwise accepted prior to or, concurrently with the payment of tuition fees or, for eligible students, request for FEE-HELP



assistance. For students under 18 years of age, the written agreement must be accepted and signed by their parent or legal guardian.

6.3. Acceptance of a place offered by Deakin College also signifies acknowledgement that this policy and fees will be reviewed and amended from time to time.

7. Enrolment in Single Unit(s) and Cross-institutional enrolment

- **7.1.** Enrolment in single unit(s) is available to a domestic applicant. However, the academic selection criteria of this policy continue to apply in assessing the applicant's eligibility.
- **7.2.** Students enrolled in another higher education provider, may apply for crossinstitutional enrolment where the unit or units undertaken at Deakin College will be credited back to their course at their home provider. Deakin College's academic criteria will apply in assessing the applicant's eligibility.
- **7.3.** Written permission from the home provider is required to approve the cross-institutional enrolment.
- **7.4.** All applicants must satisfy unit prerequisites before being permitted to undertake study in that unit.

8. Deferment of Commencement of Studies

- **8.1.** An overseas applicant who has been admitted to a Deakin College course is limited to one (1) deferment of commencement of studies to a following trimester. A domestic applicant who has been admitted to a Deakin College course can defer commencement of studies for up to a period of twelve (12) months.
- **8.2.** For overseas students, once a Confirmation of Enrolment has been issued, a deferment of commencement of studies can only be granted in the following circumstances:
 - Inability to obtain a student visa in time for entry into the trimester for which the admission application was submitted;
 - Failure to meet academic or English language entry requirements; or
 - Compassionate or compelling circumstances beyond the student's control.
- **8.3.** A written request for deferment and documentary evidence is required for a deferment of commencement of studies to be approved.
- **8.4.** Overseas students are advised that a deferment may affect their student visa and are referred to the Department of Home Affairs.
- **8.5.** Deferment will not be granted for enrolments in single unit(s) or cross-institutional enrolments. Applicants must re-apply at the time when they are ready to undertake their course or unit(s).
- **8.6.** Where a student has been granted a deferment, Deakin College will hold the tuition fees paid without penalty until the subsequent trimester, as per the Refund Policy.

9. Withdrawal of Offer



- **9.1.** Students may withdraw their offer acceptance for a course at any point in time but may be liable for fees depending on the timing of the withdrawal, as per the *Refund Policy*.
- **9.2.** Irrespective of whether an offer has been accepted, Deakin College has a right to withdraw a letter of offer where it is found that:
 - fraudulent information or documentation has been submitted;
 - an applicant has omitted to disclose their exclusion from another education provider or
 - any other information which, if disclosed, would have led to the person's application for admission to the course or unit of study being refused.
- **9.3.** For VTAC applicants, Deakin College may withdraw an offer after the offer has been released in the following circumstances:
 - Where the applicant does not enroll at the stated time on the offer letter;
 - Where the applicant has not divulged information in the application;
 - Where offers have been made in error either by courses or VTAC to applicants, and applicants of a higher standard have not, as a result of the error, been offered.

10. Readmission after Exclusion or Withdrawal from Deakin College

- **10.1.** Students who have been excluded from Deakin College due to unsatisfactory academic progress may apply for readmission after the completion of the exclusion period, usually 12 months following the conclusion of any appeals.
- **10.2.** Students who withdraw or failed to re-enrol by the last date of (re)enrolment will be required to apply for readmission to continue in their original course of enrolment.
- **10.3.** Students applying for readmission will be assessed against the Admission Criteria outlined in this policy and, may be required to apply for credit for prior learning.
- **10.4.** Students readmitted into a course may be subject to previous enrolment conditions imposed by the Board of Examiners.

11. Appeals

11.1. Applicants who have been unsuccessful in seeking admission to Deakin College and who are dissatisfied with the outcome of their application are entitled to a review of this decision by the Deakin College Appeals. Further information can be obtained from the Appeals Policy.

Applicants with work and life experience	Applicants are also required to submit a short statement articulating how they will use the knowledge, skills, abilities and personal qualities gained through life experience to succeed in their chosen course. If applicants are unable to demonstrate work experience, Deakin College will require an interview.

Domestic applicants with overseas qualifications

Domestic applicants with academic qualifications are assessed for comparability using, but not limited to, the following resources:

- a) The National Office of Overseas Skills Recognition (NOOSR) Country Education Profiles (CEPs). These can be accessed online at <u>https://internationaleducation.gov.au/services-and-resources/pages/qualifications-recognition.aspx</u>
- b) The National Recognition Information Centre (NARIC) (UK company.) NARIC can be accessed online at <u>www.naric.org.uk</u>.

Mature age students (21 years of age and over) may be admitted to a course without meeting the formal academic requirements if they have relevant work experience and other acceptable qualifications.

Appeal	A submission by a student or applicant for a review of a decision made by an officer or department at Deakin College.		
ASC	Admission and Selection Committee. The committee which provides leadership and quality assurance in all matters relating to student selection and admission into the Certificate IV and Diploma courses.		
СоЕ	<i>Confirmation of Enrolment</i> . A document registered with Department of Education and Training and Department of Home Affairs to confirm a student's acceptance into a course for a specified duration.		
Compassionate or compelling circumstances	'Compassionate or compelling circumstances' are those beyond the control of the student and which have an impact upon the student's course progress or wellbeing including inability to commence a course due to delay in receiving a student visa. These could include:		
	 (a) Serious illness or injury where a medical certificate states that the student is unable to attend class; 		
	 (b) Bereavement of close family members such as parents or grandparents; 		
	(c) Major political upheaval or natural disaster in the home country, requiring emergency travel and this has impacted upon the student's studies;		
	(d) A traumatic experience;		
	(e) Inability to commence a course due to delay in receiving a student visa.		
Course	A program of instruction.		
Course Progress	The measure of advancement within a course towards it completion.		
Cross-Institutional Studies	Single units of study undertaken at Deakin College by a student enrolled in a primary course with another education provider, where permission is		



	granted by that provider for the units at Deakin College to be credited back to the primary course.
Current Year 12 Students	A VTAC applicant who at the time of applying for courses, is enrolled in VCE, Australian Year 12 or IB studies in Australia or New Zealand.
Deakin College Appeals	A body which determines appeals from students. This is the final avenue of appeal available to students at Deakin College.
Deferment	To temporarily put studies on hold.
Department of Home Affairs	The Australian Federal Government's administrative division on all immigration and visa matters.
Domestic student	Defined as an Australian or New Zealand citizen or holder of a permanent residency visa. This term refers both to applicants and students.
DUELI	Deakin University English Language Institute. Offers a range of English language programs to prepare students for entry into a Deakin College or Deakin University course.
Genuine Student	An overseas student who intends to obtain a successful education outcome and has the language, educational and financial background to have a reasonable chance of achieving this educational outcome.
International Baccalaureate (IB)	An international organisation offering three programs of education: Primary Years Program, Middle Years Program and the Diploma Program.
Mature Age Applicant	An applicant aged 21 years and older, who does not meet academic requirements for a course but seeks to gain admittance into a Deakin College course upon demonstrable expertise and relevant work experience.
Non-Year 12 Applicant	A domestic VTAC applicant who at the time of applying for courses, is not enrolled in any VCE, Australian Year 12 or IB studies in Australia or New Zealand.
Overseas Student	For the purposes of this policy, this refers to a person on an overseas student visa or a person intending to apply for an overseas student visa.
PRISMS	<i>Provider Registration and International Student Management System</i> . A database developed jointly by DEEWR and Department of Immigration for the purposes of administering the ESOS Act.
Recognition of Prior Learning	The granting of exemptions or course credit towards at course at Deakin College based on previous relevant formal studies or upon demonstrable expertise and relevant work experience.



Special Entry Access Scheme (SEAS)	An alternative entry scheme through VTAC for applicants who have experienced short and long-term disadvantage.

Trimester	A defined and formal period of study of 13 weeks' duration which includes one non-teaching week and one examination week. Deakin College runs three formal trimesters annually.
National Recognition Information Centre (NARIC)	An agency responsible for providing information, advice and expert opinion on vocational, academic and professional skills and qualifications from over 180 countries worldwide.
Unit	A component of study within a course. Also referred to as a subject.
VCE	Victorian Certificate of Education. A certificate which the majority of students in Victoria receive on satisfactory completion of their secondary education, which provides pathways into further study and training.
VTAC	Victorian Tertiary Admissions Centre. The central office that administers the application and offer process for places in higher education courses in Victoria.
