

Deferment to Commencement of Studies Application

Standard 9 of the National Code of Practice for Registration Authorities and Providers of Education and Training to Overseas Students 2018 (the National Code 2018) and Deakin College Admissions Policy provides that a deferment of the commencement of study is only permissible on the grounds of compassionate or compelling circumstances. Such circumstances are generally those beyond the control of the student and have an impact upon the student's course progress or wellbeing. These could include, but are not limited to:

- Serious illness or injury, where a medical certificate states that the student was unable to attend classes;
- Bereavement of close family members such as parents or grandparents;
- Major political upheaval or natural disaster in the home country requiring emergency travel and this has impacted on the student's studies; or
- A traumatic experience such as involvement in, or witnessing of a serious accident or, being the victim of a serious crime.

All claims of compassionate or compelling circumstances must be supported by appropriate evidence. Students under the age of 18 years must provide a letter from their parent or legal guardian supporting the deferment to commencement of studies.
